1. **APOLOGIES**

2. MINUTES

The minutes of the Annual Town Meeting held on 28th April 2021 were considered and by way of a show of hands,

the Minutes of the Annual Town Meeting held on 28th April 2021 were formally received and approved.

3. **PRESENTATIONS**

Five presentations were given, as follows:

- New Romney Skateboard Group on the benefits of extending the New Romney Skate Park
- Folkestone and Hythe District Council on the topic of Community Led Housing
- Romney Marsh Morris on the history and activities of the Morris Side
- 1st New Romney Brownies on the benefits of participating in Brownies, the need for volunteers and the benefits of volunteering
- 1st New Romney Scouts on the benefits of scouting and the need for volunteers

Questions were put and answered on the afore-mentioned subjects.

4. ANNUAL REPORT OF THE TOWN COUNCIL

A copy of the Annual Report had been previously circulated to Councillors and made available to members of the public ahead of the meeting via the New Romney Town Council website. Hard copies of the report were also made available at the meeting.

The Mayor presented the Report, highlighting key items of interest, including progress of the proposed Community Hall and Sports Pavilion, success of the installation of protective bollards around St Martin's Field, the work of the Town Council's Parish Caretaker Team, the Council's work towards improved inclusivity and accessibility and becoming nett carbon neutral.

The Chairman of the Finance and New Romney Town Council General Purposes Committee then presented the Council's Financial Summary, highlighting expenditure on IT equipment to bring the Council into the 21st Century.

7. REPORT OF SHEPWAY DISTRICT COUNCILLORS

Councillor Wimble presented his report, which included details of District Council responsibilities and local issues that he has been engaging with, details of grant funding for local businesses, development of the Mountfield Business Hub, planning matters and the work of community hubs within the District during the Coronavirus Pandemic.

(ii) Councillor Mrs P S Rolfe

Councillor Mrs Rolfe presented her report, which included details of work undertaken in respect of local health matters as well as Ward Grants awarded during the past 12 months and work undertaken with other outside agencies, including Opportunitas and Romney Marsh Partnerships, development of the Mountfield Business Hub and the work of the community hubs within the District during the Coronavirus Pandemic. Councillor Mrs Rolfe's report was received and noted by those present, with questions having first been put and answered.

8. REPORT OF KENT POLICE/NEW ROMNEY COMMUNITY WARDEN

The written report of PCSO J Goreham, which highlighted the low crime rates in the local area over the past two years and highlighted the 'MY COMMUNITY VOICE' app, was duly received and noted by those present.

NEW ROMNEY TOWN COUNCIL FINANCIAL SUMMARY

2022/23 Budget Analysis

The Town Council's income and expenditure for the year 2022/23 is on target to balance. The cost of New Romney Town Council's services for a Band D property for the financial year was £131.01 equating to £10.92 per month or £2.52 per week. The Town Council's Precept for the year 2023/24 in the amount of £374,894.00 represents an annual cost of £127.40 for New Romney Town Council's services for a Band D property for the year – which is a 2.76% DECREASE on the previous year.

The Town Council is fully accountable to residents each year at the Annual Town Meeting at which time any questions may be raised.

The fully audited accounts for 2021/22 are available at the Town Hall for perusal by prior arrangement. The Town Council has an approved Capital Spending Plan and an approved Investment Policy which are reviewed annually, details of which are available from the Town Hall by prior request.

KENT POLICE - PCSO REPORT

It has been a busy time on the Romney Marsh as always – There is a wonderful community spirit that I often see in my work.

Speeding is a great concern to many residents and Kent Police. Life for everyone is so hectic and everyone is so busy or working to a tight time schedule that often rules of the road are forgotten. We are conducting local Policing Operations to try and address this, giving vehicle users driving at excess speed suitable advice about the dangers they are putting themselves and other road users in. At the same time, we will be looking at the road worthiness of vehicles, again giving advice and taking appropriate action if vehicles are dangerous.

Metal theft is another issue here on the Romney Marsh with reports of catalytic converter thefts becoming a problem. We ask if residents can also be pro-active in trying to prevent such thefts that are extremely inconvenient to vehicle owners. Often the cost to replace such parts is more than the entire value of the vehicle. If you have a garage, please use it when parking your vehicle at home. This can often help reduce your insurance premiums too. Thieves also do not like being seen or identified. Consider fitting wireless security cameras near areas where you park your vehicle at home and vehicle on-board CCTV cameras when parked out and about.

We have many older residents living within our community and fraud is now becoming a very common issue – scams vary from phone calls, door knockers to scam emails. May I ask, in such circumstances – remain calm and contact us via online chat, telephone, in person at the Police Station, or using the 24/7 yellow phone at the front of the Police Station where you will be connected direct to a Kent Police operator. We are here to help, advise and protect.

Often it is forgotten that we at Kent Police work closely with other agencies. Kent County Council local Community Warden covers New Romney and its surrounding area. Police, Police Staff and Wardens often work closely together to resolve and manage local issues and problems and it is reassuring that residents have this outlet too to raise concerns and problems in a more informal way. We will continue to work with other agency staff to protect and serve our community.

We now have a new online messaging service called My Community Voice. The service sends updates about your local area directly from the police officers themselves. My Community Voice is more than just a messaging service, it allows you to reply to the alerts we send you, share information and tell us about the issues affecting you.
