2023-2024 has, once again, been a very busy and productive year for New Romney Town Council. Like previous years, the Council has been pleased to support a number of community initiatives and events and further improvements to the locality have been undertaken for the benefit of residents. In addition to this, following an immense amount of work, the Town Council has now reached the momentous stage in the delivery of the 'Maude Community Centre' and annex when, in February 2024, it was able to award the Design and Build contract for this project to Kent Structures Ltd.

There are also a number of other successes that have been achieved during the course of the civic year that are definitely worthy of highlighting within this report:

## Strategic Plan 2023-2027

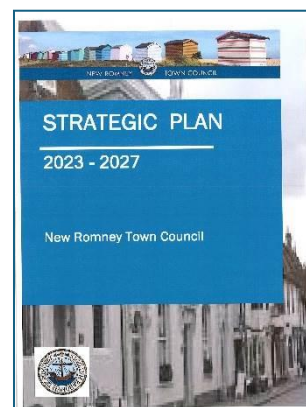
New Romney Town Council has developed and adopted its first ever Strategic Plan.

The Strategic Plan 2023-2027 describes the Council's vision for the current four-year term of office, what it is trying to achieve and what its key objectives and priorities are between now and May 2027.

This new initiative for the Town Council, is the result of a focussed workshop involving Council Members, who were able to share their ideas for the Council's priorities based on their understanding of what local residents want, need or are concerned about – understanding gleaned from direct conversations and communications as well as local social media posts.

The Strategic Plan explains clearly to Councillors, staff, residents, businesses and other local organisations exactly what the Council aims to achieve for the benefit of the Town and its residents between now and the next election. New Romney Town Council is an ambitious Council and its Members are all committed to helping make the Town of New Romney, which includes Littlestone and Greatstone, a better place to live, work and visit. This document will help the Council continue to focus on delivering excellent, value for money services for the Town and its residents.

New Romney Town Council's Strategic Plan 2023-2027 has been published and is available to view on its website.



## Partnership Working



The Town Council has, this past year, been delighted to enter into a volunteering arrangement with New Romney in Bloom. This local community group works extremely hard to bring added colour and beauty to the parish of New Romney and to assist with keeping the Parish looking attractive and tidy for residents and visitors alike. The NRIB Volunteers very kindly planted out the St. Martin's Field planters in time for the Coronation Celebrations in the early part of 2023. They have recently taken on the challenge of improving the flowerbeds at the

Princess Diana Memorial Garden in Littlestone Road (aka Flagstaff Land) and have been busy preparing the beds for planting. The Council is sure that it won't be too long at all before the fruits of all their hard work will be evident and enjoyed by everyone who passes by or rests a while in this delightful garden.

## Supporting Improved Local Health & Wellbeing

The New Romney Town Council Health and Wellbeing Committee plays a crucial role in supporting the health and welfare of the local community. By focusing on various aspects such as New Romney NHS provision, local health and wellbeing needs, and issues pertaining to the Integrated Health Board, the committee strives to address the diverse health challenges faced by residents. Through collaboration between Councillors, health professionals, and representatives from Patient Participation Groups, the committee endeavors to identify gaps in healthcare provision, advocate for improved services, and promote initiatives that enhance the overall wellbeing of individuals within the community. With a proactive approach to healthcare governance, the committee aims to foster a healthier and more resilient community, where individuals have access to quality healthcare services tailored to their specific needs. In essence, the work of the committee is integral to safeguarding the health and prosperity of New Romney's residents, ensuring that they receive the care and support necessary to lead fulfilling lives.



## Dementia Friendly Council

In September 2019, the Council resolved to “**become a Dementia Friendly Council**”.

The Council resolved that (i) all New Romney Town Council Members shall undertake Dementia-Friendly Training and that (ii) New Romney Town Council shall take steps to become a Dementia Friendly Council.

Many Councillors received the initial training and it has now been scheduled to be repeated in June 2024 so that all Councillors can receive or refresh their training and the current Council can continue to develop as a ‘Dementia Friendly’ Council. Cllrs Rivers and Thomas continue to sit on the Romney Marsh Dementia Forum.

Work has progressed on adapting Town Council buildings (Town Hall and Assembly Rooms) to make them more dementia friendly. The lighting in the Assembly Rooms and in the Council Chamber at the Town Hall has now been replaced with improved LED lighting, reducing areas of shadow and, thereby, assisting to reduce confusion for dementia sufferers. The provision of signage for the Town Hall and in the Assembly Rooms to assist dementia sufferers is currently in hand.



## Climate Emergency



As previously reported, New Romney Town Council resolved to declare “**a Climate Change and Ecological Emergency, with the aim of making its activities nett carbon neutral by 2030**”.

The Town Council was the first in Kent to complete the Kent Association of Local Councils (KALC) Carbon Footprint Calculator and identify potential areas for improvement.

The Council has subsequently continued to move steadily towards becoming paper-free – with the vast majority of Town Council communications now being dealt with entirely electronically and the use of paper in respect of routine Council business and transactions significantly reduced.

Most recently, the Town Council approved quotations to replace Town Hall waste receptacles and to upgrade its waste collection subscription to accommodate the recycling of Town Hall waste. In addition to this, lighting in the Assembly Rooms and in the Council Chamber has now been replaced with low energy LED lighting and electricity supply meters have been upgraded to smart meters.

Where possible, appropriate and practical, meetings other than Full Council and Committee meetings continue to be held remotely to reduce the Council’s carbon emissions due to travel (eg working party meetings / meetings with outside bodies or other third parties).

The Town Council Office now officially operates a four-day week, since all staff are part-time employees and the closure of the Town Hall for one additional day per week has enabled energy saving as well as cost saving. It should be noted, however, that, despite the move to operating an official four-day week, public accessibility to Council services via the Town Hall offices has, in fact, increased from three mornings per week to four mornings per week.





## Accessibility

The Council has continued working on exploring and improving the issues of accessibility at the Town Hall and Assembly Rooms, having assessed the recommendations of relevant Access Audits commissioned by the Town Council.

A number of small accessibility improvements were actioned early on, including the installation of doorbells at the Town Hall and the Assembly Rooms to call for assistance in gaining access and adaptations to the rear threshold at the Assembly Rooms to allow improved access for wheelchair users. Continuation of this work has subsequently been incorporated into the Town Council's recently adopted Strategic Plan for 2023-2027 and, most recently, the replacement of the Town Hall stair lift has been completed, providing greatly improved access to the Council Chamber with a stair lift that can now also accommodate wheelchair users.

The Council has been holding all Town Council meetings in the Assembly Rooms during the past two years due to the unreliability of the chair-lift access to the Council Chamber. However, it is now possible to return Council Meetings to the Council Chamber at the Town Hall. In light of this, the Council is currently exploring replacement of the existing large meeting tables and chairs to improve ease of movement around the Council Chamber for Councillors, staff and visitors alike.

## Parish Highway Improvement Plan

New Romney Town Council is pleased to report that, with assistance from Kent County Council, it has developed a **Parish Highway Improvement Plan for New Romney.**

The aim of the Parish Highway Improvement Plan is to look at all of the **Road Safety** issues we have in New Romney, Littlestone & Greatstone and develop a coordinated plan of improvements to address identified road safety shortfalls.

This allows us to identify and prioritise road safety improvements such as:

- Reduce Speed Limits
- Parking Restrictions
- Speed Monitoring
- Road Layout
- Signage
- And much more



Following a series of public engagement events, the Highways Improvement Plan has now been approved and published on the Town Council website.

In order to commence implementation of the PHIP (Parish Highway Improvement Plan), New Romney Town Council (NRTC) has had four meetings with Kent County Council (KCC) in the last 12 months. The most recent was regarding the outcome of 9 x traffic surveys and 1 pedestrian survey to cover Zones 1 & 2 of our Highway Improvement Plan. All areas surveyed were deemed suitable for a 20MPH limit and Brissenden Close & Richmond Drive have also been added into the 20MPH zones.

There are concerns over the speeds in Cockreed Lane being too high to implement the 20MPH limit and other options are being investigated but it still may be possible to place a 20MPH speed limit.

Kent County Council have communicated an Extents Plan outlining our proposed changes – a public engagement meeting was held in February 2024 at the Assembly Rooms, attended by over 40 residents.

KCC have installed the new Church Approach one-way signage; we have also requested that the white Lines for Ashford Road junction onto the High Street are repainted (KCC Reference 754211).

Just a reminder that we have received the 30 MPH toolkit from Kent County Council which consists of banners and stickers that residents are welcome to collect from the Town Hall to display at their properties or place the stickers on their bins to remind others of the speed limit within their

roads/streets. These self-adhesive stickers/signs are a great way of raising awareness of speed limits in residential and built-up areas within our Parish and we would encourage all residents to use them on their bins/properties in a 30 MPH zone.

“Not suitable for HGV vehicles” signage has been ordered for Spitalfield Lane & Sussex Road. The size and location of these new signs has also been agreed with KCC.

One of the key areas of concern for residents highlighted during our 7 public engagement meetings was congestion within the High Street caused by problem parking and bottle necks.

After discussions with both Kent County Council and Folkestone and Hythe District Council a plan has been developed to rearrange the parking within the High Street to allow for better free flow of traffic which will avoid congestion, by preventing parking on one side of the whole length of the High Street from The Ship Hotel to the Cinque Ports pub. Additional parking will be created on the opposite side of the High Street. The changes suggested will only lose 2 parking spaces in total to the High Street and gain an additional disabled parking bay. This strategy was agreed at the Joint Transportation Board meeting between KCC and FHDC in November 2023.

## IMPROVEMENTS TO THE LOCALITY

### St. Martin’s Field



During 2023, New Romney Town Council completed its ‘Queen’s Green Canopy’ project with the installation of a Platinum Jubilee Commemorative Tree Bench.

The Council also installed a commemorative bench on St. Martin’s Field to celebrate the Coronation of King Charles III.

With the generous assistance of New Romney in Bloom work is on-going with developing the pollinator-friendly flower-bed on St. Martin’s Field.

### The Greens, Littlestone / Fairfield Road Recreation Ground / St. Martin’s Field

The Parish Caretaking team has been busy over the recent months replacing ageing litter bins at the Greens as well as Fairfield Road Recreation Ground and St. Martin’s Field - and this programme of work has now been completed.

The new bins are equipped with vermin flaps to assist in reducing access by seagulls in particular - and will be helping to keep New Romney free of litter.



## Princess Diana Memorial Garden (Flagstaff Land)

The installation of new bollards around the boundary of the Princess Diana Memorial Garden has now been completed. The new boundary bollards certainly help to bring a new lease of life to the garden, whilst also protecting the area from unauthorised incursions. Following deterioration of the flagstaff, this was recently removed and a replacement purchased. Installation of the replacement flagstaff is currently in hand.



New Romney in Bloom has been working very hard to prepare the flowerbeds for spring/summer planting and its volunteers will be continuing to give up their time throughout the coming year to transform the rockery beds and bring some much-needed additional colour to the area.



## Town Trail Installation Completed



Following the winding up of 5<sup>th</sup> Continent, New Romney Town Council took receipt of a number of plaques which form a New Romney Town Trail as well as two town maps. The Town Trail plaques have now all been installed by the Council's Parish Caretaker around New Romney and Littlestone and the two town maps have also been installed in West Street Car Park and Church Approach. Visitors to the Town as well as residents will now be able to make the most of the approaching better weather to enjoy learning a little more about our local history.

## Supporting Improved Local Biodiversity

The Tree Nursery that was developed adjacent the Allotment Gardens in Church Road by the 1<sup>st</sup> New Romney Scout Group, working in partnership with New Romney Town Council, is doing well and the saplings are continuing to grow steadily stronger. It is envisaged that once the saplings are adequately established, they can be distributed for re-planting within the parish.

This year, New Romney Town Council gave consent for the installation of a number of beehives at its land in Church Road. The beehives are looked after by Marsh Apiaries and the Town Council is delighted to support this work to increase the presence of these important pollinators on Romney Marsh.



New Romney in Bloom's volunteers have commenced work on numerous areas of Town Council land to tidy up borders and flowerbeds and bring some additional colour to the Town – whilst also assisting in increasing pollinator-friendly planting where appropriate. The Town Council is very grateful for their generous support in looking after our Town.

## IMPROVING LOCAL LEISURE FACILITIES AND BUILDING COMMUNITY SPIRIT

In February 2024, New Romney Town Council confirmed the exciting news that, having been awarded planning consent in December 2023 for its new, budget-led project and following a stringent tendering process, it had awarded a Design and Build Construction Contract for the newly-named 'Maude Community Centre' and Annexe, which is to be sited adjacent to the Station Road Sports Ground.



In February 2022, the Council had taken the decision to halt the original project and to re-design it, to be delivered within a fixed budget. In January 2023, the Town Council agreed to move forward with a revised, fully costed design that could be achieved within the available budget. Further engagement then took place with key stakeholders to refine the project design.

In September 2023, a new project planning application was submitted to Folkestone and Hythe District Council and the contract opportunity was publicised. The deadline for receipt of tenders was 11<sup>th</sup> December 2023 and on 12<sup>th</sup> December 2023, the new project design was awarded planning consent – which was excellent news!

On 7<sup>th</sup> February 2024, having completed a stringent tender review and interview process, which was supported by Synergy Construction & Property Consultants, the Town Council formally awarded the £3.3 million contract to deliver the project – which has now been named the 'Maude Community Centre' – to Kent Structures Ltd.

New Romney Town Council is delighted to have been able to award this exciting contract opportunity to a local company, Kent Structures Ltd, which is located in Ashford - thus aligning the Council's decision with its ethos of supporting local economy whenever possible.

Work will commence on site on 29<sup>th</sup> April 2024 and is due to be completed by 28<sup>th</sup> April 2025. The new Maude Community Centre, once officially opened, will provide a main two-storey building and a single-storey annexe. These new facilities will be home to a wide range of much-valued community services, including a community sports pavilion which will become the new home of New Romney's local sports teams, a 150-seat community hall available for hire by local groups and organisations, as well as private hire for family parties, wedding receptions and other family functions and for community events, business conferences etc, and facilities for daily childcare provision.

Delighted by New Romney Town Council's decision to now see this project through to fruition, Chairman of the Project Steering Group, Councillor Paul Thomas, stated: *'The Project Steering Group has worked hard over the last two years, in a difficult financial environment, to work with key stakeholders on finalising a deliverable design which has now received planning consent. I look forward to the opening of the Maude Community Centre and Annexe in April 2025, which will transform the existing site and I am delighted that we have retained the Maude name.'*



The Right Worshipful the Mayor of New Romney, Councillor John Rivers added: *'This project will prove to be an important step forward for our community and shows that the Town Council takes seriously its responsibilities as our population grows and as the demands on leisure spaces increases. Important for mental and physical health, this brand new, modern facility will promote healthy living and social benefits for all. I look forward to the provision of these facilities in the second quarter of 2025'.*

## MAINTAINING NEW ROMNEY'S HISTORIC LINKS

### My experience representing New Romney at the Coronation of King Charles III

In April 2023, we received a communication from the Registrar and Senechal of the Cinque Ports.

"I am pleased to inform you that the claim of the Barons of the Cinque Ports to their historic "Honours at Court" has been allowed to the extent of allocating 14 seats at the Coronation. I understand that this will allow attendance at the ceremony in Westminster Abbey but will not include the performance of any specific duties, such as the Barons have undertaken in the past. Formal written invitations will follow and further information, including precise timings, dress code and entry arrangements will be issued nearer the date.



In the absence of the Lord Warden and in accordance with instructions given by the General Brotherhood of the Cinque Ports in 1812, the Speaker has determined that one seat should be allocated to each of the 14 member towns of the Confederation. In accordance with ancient tradition, the Speaker has issued a formal written "precept".

This was followed with an official invitation to the Coronation from Buckingham Palace.

On Saturday 6th May 2023, King Charles III was crowned, in the sight of God and his people. As a Baron of the Cinque Ports, I represented New Romney at his Coronation Ceremony; it was a very humbling experience and one I will never forget.

The back story of how New Romney became a Cinque Port and how the Mayor gained the title of Honorary Baron is an interesting one. It all started in 1041, when Edward the Confessor set out his requirement to the south coast Portsmen to use 20 of their ships, each with a crew of 21, for 15 days of service annually. William the Conqueror's Charter (written then in old French), coined the term "Cinque Ports" as at that time there were only five recognised ports and William's requirement was for the annual provision of 57 ships for 15 days. Cinque Port Barons were first invited to coronations by King Richard I (known as



the Lionheart) Coronation on the 3 September 1189 as King of England. Richard's coronation ceremony was remarkable as it was the start of contemporary accounts being recorded.

For almost a thousand years, Westminster Abbey, with the Shrine of St Edward, King and Confessor, at its heart, has remained the place of coronation for our monarchs. The Cinque Port Barons, by tradition, carried the canopy over the monarch as he or she walked to and from the coronation. Afterwards, the Barons normally shared the canopy and New Romney has a section of the canopy from

George II in a display case in the Town Hall.

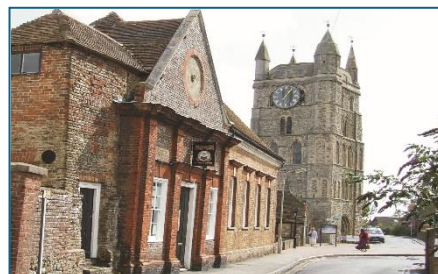

### QUESTIONS SUBMITTED IN WRITING BY A REGISTERED LOCAL GOVERNMENT ELECTOR FOR NEW ROMNEY (NAME SUPPLIED)

1. I attended the public meeting at the Assembly Rooms on 10 April regarding Poor Local Bathing Water Quality and found some of the comments of residents and businesses heartbreaking. I knew there was an issue but did not realise it was so serious, a great risk to public health and detrimental to the local economy, some businesses have closed, and tourist numbers have been reduced as a direct result.

Unless it has decided to already, will the Town Council consider writing to the Secretary of State and the CEO of Southern Water expressing its deep concern about this issue and emphasising the need to get this matter resolved as a matter of urgency? May be doing this together with other nearby parish/town councils or encouraging them to do likewise may help emphasise the impact that this is having in this part of Kent and East Sussex.

New Romney Town Council is, indeed, very concerned about this issue and is already considering a range of potential actions. In fact, the Council has just approved expenditure for the purpose of undertaking regular water quality monitoring, which will inform and support the case for concern when lobbying for this issue to be resolved.

2. The Maude Community Centre

It is wonderful news that building is to commence on 29 April and is due to be completed on 28 April 2025. With hindsight, reflecting back over the period since the project began

a) is there anything that the Town Council would do differently, and if so what?

As per industry standard, the Town Council will conduct a post-project review of this project following completion and the outcome of that review will be published on the Town Council website.

b) is the Town Council content that it has got and is getting "value for money" for the build and non build costs?

The Town Council, having gone through a detailed re-design process when its original design proved to be financially un-deliverable, has now been able to award a Design and Build contract within a set budget. In order to ensure best value, the Council not only engaged in a stringent tendering process led by a professional and well-reputed project management and design team but also, due to the anticipated value of the contract, advertised the contract opportunity nationally via the government contract finder portal to reach the widest possible audience.

The Town Council could never deliver a project of this scale and requiring this level of technical expertise without employing professional experts and it is the employment of a well-reputed professional team that has enabled the delivery of this project. Therefore, the Council is, indeed, content that 'value for money' has been and is being achieved for the build and non-build costs of this project.





## **Tony Hills KCC member for the Romney Marsh Division Annual Report April 2024**

### **The KCC economy**

Kent is facing severe financial pressures. We are not alone, we are seeing major growth in 'adult social care', childcare, and 'home to school transport'. These we must deliver by law. So, to square the circle, we must reduce spending on other services which we would like to provide for our communities.

### **Highways**

Following a further reduction in funding. I'm asking my Highways officers to prioritize safety to the public. footways, cycles as well as cars.

Reporting problems online really helps, the more reports the better, it all helps.

I have requested financial support at the Site Stakeholders Group at Dungeness from the Nuclear Restoration Services to support Kent to construct 'Hammonds Corner' roundabout (A259); As I said last year, we now have a design for the roundabout. Dungeness A demolition will need a lot of road transport. We need funding.

### **Dungeness 'A' Station site reuse.**

I have over this last year been campaigning for the existing 'A' site to be considered for 'hi speed' demolition. Making it available as a site for a new SMNR (small modular Nuclear Reactor). If the government decides to go down this route, it will have my support.

### **Climate Change**

Is the biggest single long term threat to the Romney Marsh. Yes, we have our sea defences in place, over the last twenty years I have been working with the Environment Agency to protect the Marsh coastline from storm events.

We now face a rising level of extreme weather events, this is causing 'flash' surface water flooding all over the County.

But the Romney Marsh has been hard hit this winter with many homes flooded. I have been working with Southern Water to make sure that their equipment is working as it should. It is obvious to me that we need to increase the storm water capacity. I have set up a 'Water Management Working Group' the membership includes Southern Water, Environment Agency, and the Romney Marshes Area Internal Drainage Board. This group will meet to identify ways of managing the threat of rising ground water.

### **Water Quality**

We have had poor water quality results in the southern end of Hythe Bay again over the last year. Sadly, this has led to the Environment Agency to recommend 'no bathing' in the sea at St Marys Bay and Littlestone beaches this year. The Environment Agency and Southern Water are working hard to find sources of pollution and fix them. I will monitor the work in hand and continue to push Southern Water to increase its capacity to store more water and manage the overflows.

## **Bus Transport**

This continues to be difficult area, rising costs and low usage are a threat to our ongoing bus services. But some good news, after many years trying to bring a community bus provision to the Romney Marsh, Kent County Council working with the Romney Marsh Community Hub are developing a 'Dial-a-ride' service for the Marsh which will allow residents to get to hospital appointments etc.

## Five arrested after businesses burgled in Folkestone and Romney Marsh

Five people have been arrested by police investigating burglaries at businesses in the Folkestone and Romney Marsh areas.

Between Wednesday 27 March and Monday 8 April 2024, Kent Police was alerted to seven break-ins or attempted burglaries in Folkestone, Hythe, Dymchurch and St Mary's Bay.

An investigation was launched and officers from Folkestone's Local Policing Team identified a vehicle potentially linked to the incidents.

On the evening of Wednesday 10 April, that vehicle was spotted and stopped in Romney Marsh and five men were arrested on suspicion of burglary.

### Items seized

Items thought to be stolen have been seized and the suspects, who are aged between 18 and 70, remain in custody while an investigation continues.
